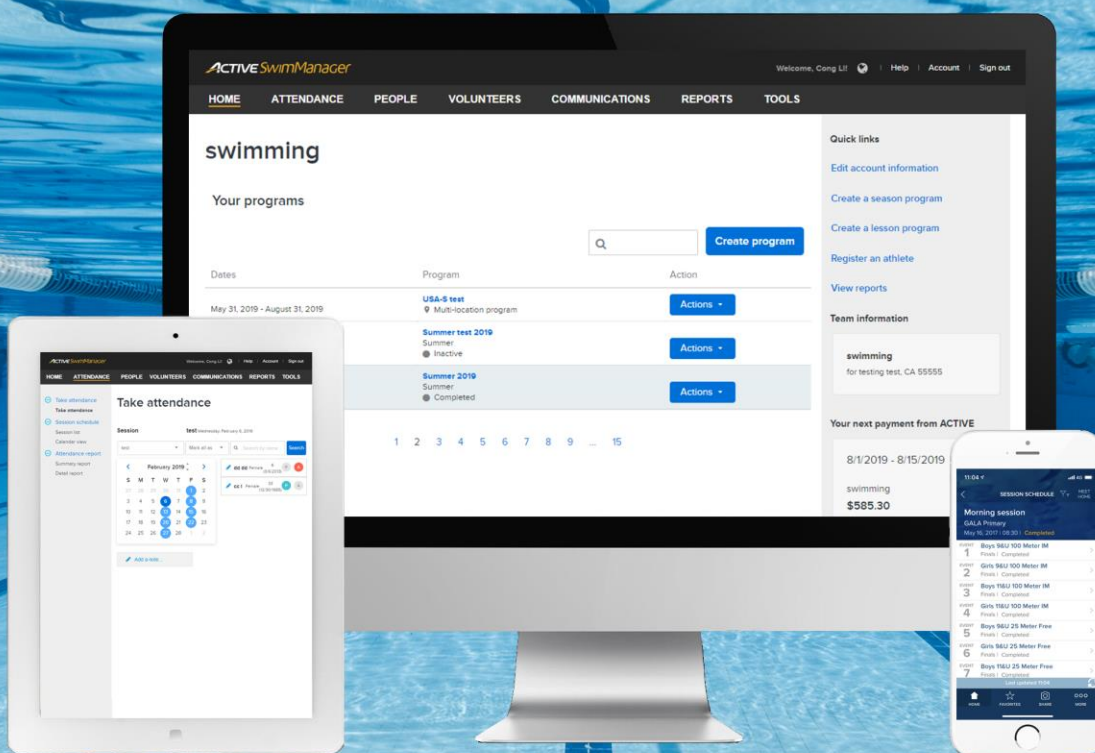

USA Swimming: FINA-related Questions

For compliance with USA Swimming requirements, when an athlete registers for a USA Swimming program or edit a USA Swimming program registration, the following enhancements have been made to FINA-related questions:

- The previous **FINA Federation** dropdown has been replaced by an **Are you a member of another FINA Federation?** checkbox (defaults to unchecked).
- In the country dropdown list, the *United States* option has been removed.
- A new **Have you represented any non-USA FINA Federation in Intl. Competition?** checkbox has been added (defaults to unchecked).
 - Note: only check this checkbox if the athlete has competed internationally for another FINA country.

- AUI > **PEOPLE** tab > an athlete > a registration > **Edit registration** > **USA Swimming Registration** section
- CUI > register a participant > **Swimmer's Information** > **USA Swimming Registration** section
- Portal > an order > required group > **USA Swimming Registration** section

Legacy **FINA Federation** dropdown answers are migrated to the new questions as follows:

- If the legacy answer was *United States* or *None*, then answers to the new questions are:
 - **Are you a member of another FINA Federation?:** unchecked
 - Country dropdown: *Select one*



- **Have you represented any non-USA FINA Federation in Intl. Competition?:** unchecked
- If the legacy answer was a non-USA option (for example, *Canada*), then answers to the new questions are:
 - **Are you a member of another FINA Federation?:** checked
 - Country dropdown: previous answer (in this case, *Canada*).
 - **Have you represented any non-USA FINA Federation in Intl. Competition?:** unchecked
